Seller/Consigner has the privilege to no-sale or pass out on horse. If the horse is passed out, the cost will be the catalog fee of \$65 plus no-sale fee. The catalog fee is non-refundable. Bismarck Livestock Auction Soundness Guarantee applies to all catalog entries. Seller/Consigner is responsible for declaring HYPP status of impressive bred horses. **CONSIGNOR AGREES TO NOT PRIVATELY SELL OR WITHDRAW CONSIGNED HORSE TO SALE unless injured/sick with vet release. NO ALLEY TRADING IS ALLOWED.** This is a contract. You are consigning your horse to sell that the horse sale. Horses are advertised and expected to sell at the horse sale.

Canadian Consignors: You will need a Canadian brand inspection (manifests are not accept by the State Brand Office), a coggins, and a current health certificate.
